#### **Additional Notes**

(1)Voya Fixed Plus Account III - Voya will credit interest at an annual effective rate of 3.00% through 12/31/2017, 2.50% from 1/1/2018 through 12/31/2018, which is higher than the standard Voya Fixed Plus III credited rate. Beginning 01/01/2019 and thereafter, the credited rate for your plan will be the same as the standard Voya Fixed Plus Account III credited rate in effect at that time. Please note the Guaranteed Minimum Interest Rate is 1.00%. Guarantees are based on the claims-paying ability of Voya Life Insurance and Annuity Company. Restrictions may apply to transfers of funds from the Voya Fixed Plus Account III to other contract investment options. Please refer to your product prospectus / disclosure booklet or call your 800 number for more information.
